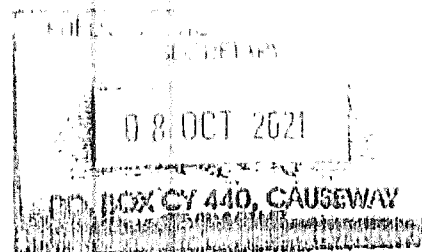

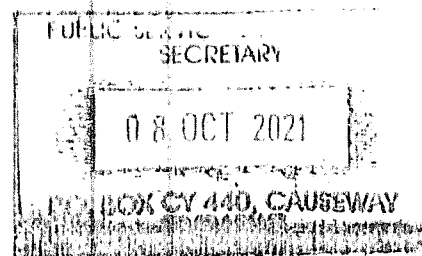

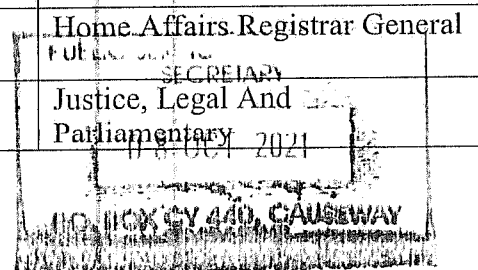

The Commission approves compensation in lieu of the condition of service vehicle in the amount of the RTGS equivalent of US\$10,573.63, representing the difference between the initial and reviewed amounts. The General Manager, Payroll Management is therefore instructed to disburse the benefit equivalent to US\$10,573.63 to the listed members. The Head of Ministry is advised to establish, before payment, that the beneficiaries were indeed not issued official vehicles as compensation for legacy debt, to avoid double payments.
